Executive Summary

On July 28, 2009, ESS submitted an application for the certification of the “*Release 4.0.0.3, Version 1*” system. This system includes the M100 and the DS200 precinct scanners, the iVotronic touchscreen, the AutoMARK Voter Assisted Terminal (VAT) system and the Model 650 central count scanner.

This system configuration provides upgrades to the DS200 tabulator and ERM election reporting manager software. Additionally, the AutoMARK VAT firmware and AIMS software have been upgraded to allow for the enabling of the AutoCAST feature.

This feature provides a new functionality for the processing of marked ballots. Hardware items used in conjunction with the AutoCAST include a ballot feed insert and a ballot box that affixes to the rear of the AutoMARK unit. This feature may be enabled or disabled by an election administrator. When enabled, the VAT will present the voter with the option to feed the ballot into the ballot box or return the marked ballot to the voter for scanning through a precinct tabulator. If this feature is selected, the ballots will be fed into the ballot box. After the polls have closed, the elections official will be required to remove the ballots and scan them through the precinct tabulator.

In addition to functional testing, the Bureau of Voting Systems Certification analyzed the system’s source code. The results of this review were submitted to the vendor and the final outcome has been documented in the proprietary addendum to this report.

Background:

The “*Release 4.0.0.3, Version 1*” system is based upon the currently certified “*Release 4.0.0.2, Version 2*” system; certificate dated April 7, 2009. This system included changes to the DS200 firmware (application) version 1.3.7.0 and an upgraded Intellect Plastic Ballot Box. The DS200 version 1.3.8.0 firmware contained two changes from the previous firmware version (1.3.7.0):

- 1) Verify correct removal of a temporary Linux operating system log file by running a script. The most obvious symptom was the inability to calibrate the touch screen because the calibration utility couldn't create the file that contains the calibration data.
- 2) Given the DS200 is an embedded system, the vendor wanted to detect any file system errors that may be caused by a fault or failure of the compact flash card. This updated version adds a file system check script to the initialization to perform a check on each of the three partitions upon every boot.

The two changes listed above required the source to be recompiled and the version number to increment. On February 12, 2009, two staff members of the bureau attended the trusted build of the source code at Systest Laboratories in Denver, Colorado. As a result, the application source code, build system environment images and trusted build files were transported back to the Division of Elections in staff custody. The functional review of the DS200 was completed and the system was certified as “*ES&S Voting System, Release 4.0.0.2, Version 2*” on April 7, 2009.

Conduct of Tests:

The test objectives are to verify that the “*Election Systems & Software, Inc. Release 4.0.0.3, Version 1*” voting system meets the applicable requirements of Florida Statutes and Florida Voting Systems Standards (FVSS).

The FVSS qualification tests include two phases: Phase I, which consists of a system audit, Unity setup, and the reuse of the multi-language (English, Spanish, and Haitian Creole) election definitions with audio. The primary and general elections use ballots by precinct ID and the municipal election uses ballots by ballot style. The Bureau used the same election definitions created during the Unity 4.0.0.1 qualification tests in November 2007. In addition, the Bureau obtained sample 2008 primary and general election definitions from Miami-Dade County using ballots by ballot styles and a compressed layout. The Phase II test matrix included early voting, multiple page ballots, multiple ballot page sizes (common page size per election) with three and four ovals per inch, universal primary contests (UPCs), split precincts, polling place mode, etc. The Phase II test simulated mock elections for pre-election setup, early voting, election day voting, provisional voting, absentee voting, and post-election activities.

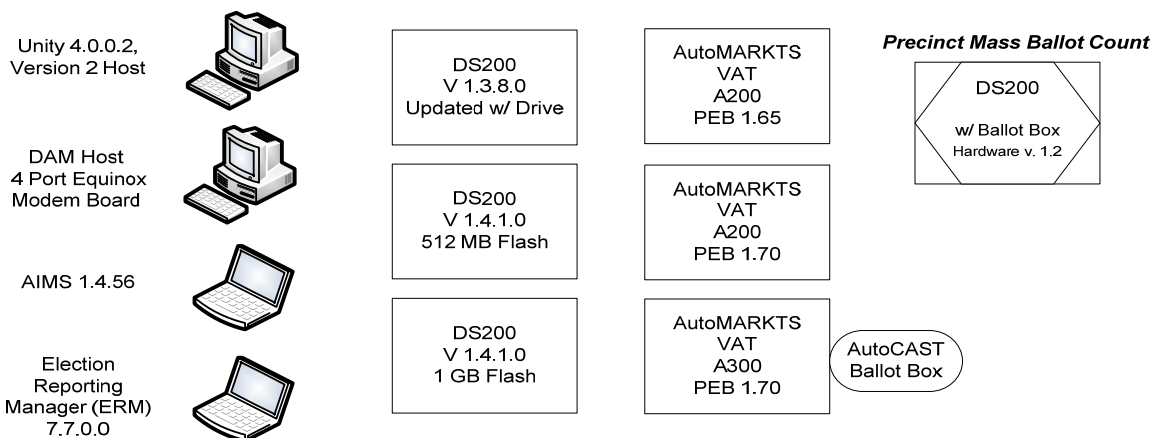
The Election Reporting Manager software version under test included an increase in the user-definable reporting groups from five to fourteen. As such, functional testing included the use of the fourteen groups for reporting purposes in the four simulated elections.

The application firmware for the DS200 precinct count scanner is new to Florida. Thus, the voting device needed to complete a mass ballot count test for a single unit casting a minimum of 9,900 ballots. Additionally, the upgraded Election Reporting Manager (ERM) required functional review for the direct upload and modem upload of results. As such, a modem test was performed using the M100, DS200 and iVotronic equipment.

The AutoMARK VAT includes a new functionality for the processing of marked ballots; this function is called AutoCAST. Hardware items used in conjunction with the AutoCAST include a ballot feed insert and a ballot box that affixes to the rear of the AutoMARK unit. This feature may be enabled or disabled by an election administrator. When enabled, the VAT will present the voter with the option to feed the ballot into the ballot box or return the marked ballot to the voter for scanning through a precinct tabulator. If this feature is selected, the ballots will be fed into the ballot box.

The bureau also utilized qualified ES&S flash drives in the phase II simulated elections and for the mass ballot count test. These tests were performed using the qualified flash drives provided by the vendor and are the only drives to be used with the DS200.

Test Results and Findings of Compliance

The bureau completed successful qualification tests for the following activities:

Phase I

DS200 Mass Ballot Count and Ballot Sensitivity Testing

- **Mass Ballot Count Test**

The DS200 counted 11,000 ballots consisting of 481,500 oval positions, without error. The hardware functioned as expected during the mass ballot count with a single DS200 and a single ballot box. The test included six separate primary precincts, 18 ballot styles with ballots by precinct identification and party to include nonpartisan, republican and democrat.

- **Test Deck and Marking Devices**

The test team used the primary election ballot test deck to evaluate the DS200 scanner sensitivity. This test was performed on one scanner unit utilizing ballots marked in such a way as to determine the scanners ability to read varying marking devices. The marking devices used in this test include the following:

- Ink Pen
 - Red (Pilot® G-2 05), Blue (Pentel® RSVP), Green (Papermate®), Black (Pilot® G-2 07) and Pigma® Micron 08 #1 Archival Ink)
- Pencil Staedtler Mars Lumograph Drafting Pencil Set
 - European Grade: 6B, 5B, 4B, 3B, 2B, B, HB¹, F, H, 2H, 3H, 4H
- Highlight Markers
 - Yellow (Major Accent® Highlighter)

- **Conclusion**

The DS200 scanner is able to detect a wide variety of marks made by various devices. These devices include ink pen, markers, highlighters and pencil. The harder pencil grades of 3H and 4H did not register as being detected by the scanner. As such, the vendor should clearly document the recommended grade of pencil. The ballot test deck used in this test has been included for reference in Appendix A.

Findings:

- AutoCAST Ballot Box

Background:

The AutoCAST feature, when enabled, will present the voter with the option to feed the ballot into the AutoCAST ballot box or return the marked ballot to the voter for scanning through a precinct tabulator. If this feature is selected, the ballots will be fed into the ballot box. This ballot box is designed in such a way as to be affixed to the rear of the AutoMARK VAT and is constructed of cardboard material. However, it has been determined that this box does not provide a sufficient level of security for marked ballots or provide a method for sealing the opening. Additionally, the cardboard is not a durable material. Functional use of the tamper evident plastic seals resulted in the box material tearing when the seals were removed.

Status:

The State of Florida will not certify the use of the current design of the AutoCAST ballot box. The state suggests a more durable design, as well as the addition of a method for securing marked ballots during the election process. The vendor may provide a change to this ballot box and have it examined as a future revision to this system's certification.

Summary:

This version of ES&S' Unity voting system offers a blended system that includes the M100 optical scanner and/or the DS200 digital scanner with the assessable iVotronic touchscreen and/or the AutoMark VAT. Test results confirmed the hardware and software functioned as expected and meets the FVSS requirements.
