2017 Special Category Grants Final Ranked List

The Florida Historical Commission met on September 24 and 25, 2015 at the Heritage Hall Auditorium in the R.A. Gray Building, 500 S Bronough Street, Tallahassee, Florida 32399. Commission Chair, Ms. Marion M. Almy, called the meeting to order at 9:05 a.m. on September 24, 2015. The Panel reviewed 53 Special Category Grant applications with a total funding request of \$14,654,045. The Panel recommended 50 Special Category Grant applications for funding totaling \$13,261,485.

The recommended applications were prioritized by averaged score. The prioritized list has been approved by Secretary of State Ken Detzner, and was sent to the 2016 Legislature for funding consideration.

## Panelists Comments:

1. One person said that the data the state has would help convince legislators to fund historic preservation.

Deputy Secretary of State Post expressed her and Secretary Detzner's gratitude for the Commission's time and service to the state.

3. Chair Almy thanked everyone for beating the drum about historic preservation.

## Public Comments:

 One applicant said he was very impressed with how the state manages these funds and thanked everyone for their work.

One applicant said that as a taxpayer and a grant recipient, he is thankful to the staff and commission for their work and the transparency of this program that makes good use of tax payer dollars.

The Florida Historic Commission 2017 Special Category Grant Application Review meeting was adjourned at 11:22 a.m. on September 25, 2015.
